- Fuel transactions are automatically extracted, geocoded, and processed for reporting daily
- All transactions are compared to vehicle and driver log files from Geotab
- Automatically performs location analysis for every transaction to determine if the vehicle was present during the fuel transaction
- Automatically tracks fuel used overage by comparing fuel purchased to fuel spent by vehicle
- Data scopes controlled by security in Geotab is honored

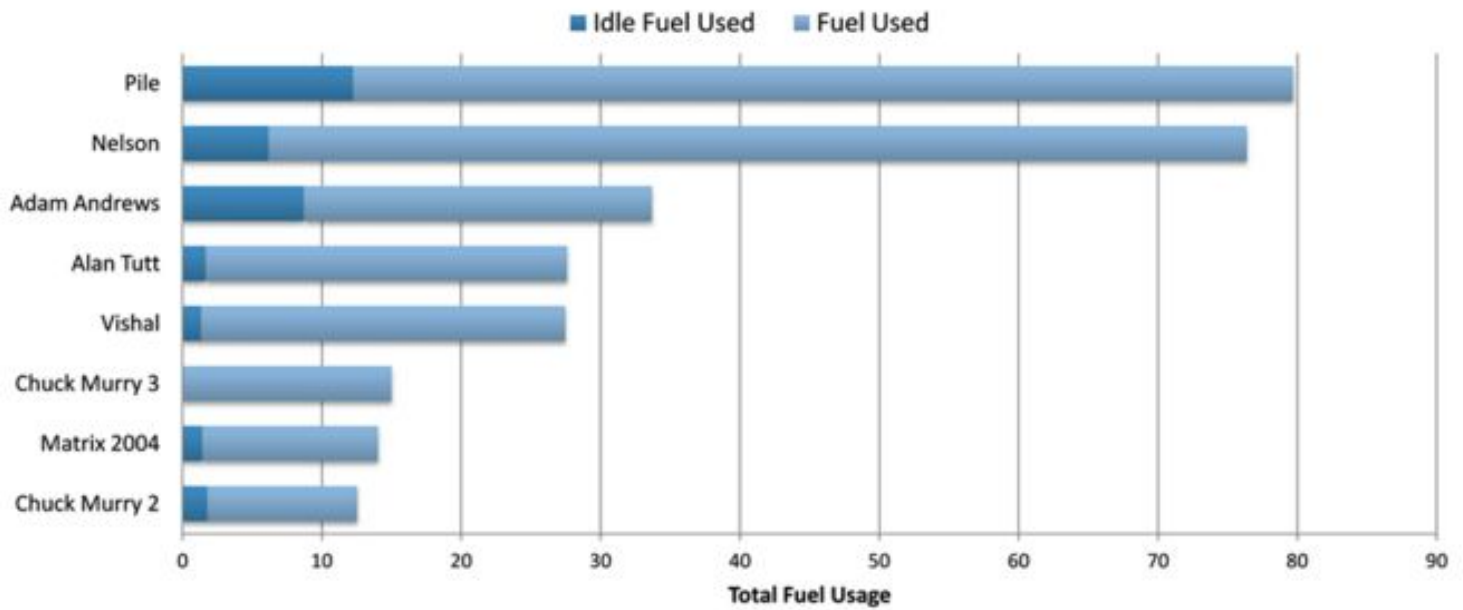
- Supply daily transaction files
